Dear Sir / Madam

The USL Toscana Centro Company (hereinafter "the Company") informs you that, in order to obtain the maximum effectiveness of the quarantine and the fiduciary isolation, specific hotel structures have been identified as they act as collective assistance structures where it is possible to ensure the isolation required for the following patients:

- paucisymptomatic (few symptoms), without the need for hospitalization, just swab-positive;
- discharged from the hospital in stable but still positive conditions;
- in the absence of a buffer in which the need for a quarantine period has been indicated.

The Company has entered into a specific agreement with the hotel where you will be staying (both are Data Controllers for the parts of their competence) defining, among other things, that the data will be processed in full compliance with the rules on protection of personal data. *In particular, pursuant to EU Regulation 2016/679 "General data protection regulation (hereinafter" GDPR) "and Legislative Decree 30 June 2003, n. 196 "Code regarding the protection of personal data", as well as pursuant to Legislative Decree March 9, 2020, n. 14 "Urgent provisions for the strengthening of the national health service in relation to the COVID-19 emergency") and Order of the President of the Tuscan Region Council no. 15 of 18/03/2020.*

For the time necessary to pursue the purposes they were processed for, without prejudice to the longer time necessary to fulfill legal obligations due to the nature of the data or document, for reasons of public interest or for the scope of public powers .

Who will process my data?	Your personal data, including health data, will be processed by duly authorized and trained company personnel or by subjects as managers designated by the Company.
Which rights do I have?	Regarding to your personal data provided by you in the context of the epidemiological emergency COVID-19, you have the right to obtain • access • rectification • cancellation • limitation of the processing • opposition to processing. For further information, see articles 15-22 of EU Reg. 679/2016. You can exercise your rights by writing to the email address of the Data Controller or Data Protection Officer.

Who can I complain to?	If you think that your rights have been violated, you have the right to lodge a complaint with the Guarantor Authority for the protection of personal data through the method indicated on the website www.garanteprivacy.it .
